
PRESENTE

- 3- Participar la exhibición de una muestra de obra bidimensional en la ciudad de Estambul.
4. Presentación de portafolio profesional al público asistente.

YALOVA ULUSLAR ARASI SANAT BİENALİ

We will be traveling to Yalova from August 20 to September 20, 2010

Contract

between Asri Sayrac, Network FLUSS

and the artist *Armando Gómez Martínez*

According to the contract between mayor of the City of Yalova, Vefa Salman, and Network FLUSS manager Asri Sayrac, the following agreements were made.

In this contract I am passing the agreements on to the individual artists.

The responsibilities of Yalova

- Bear the cost for the airline tickets, but for the participants from Mexico, Japan, Iceland and Greenland, whose flight will be paid only partially with 300,00 €.
- Pick up the artists from the airport in Istanbul and take them back for departure.
- Provide the artists room and board and a place to work for the duration of the exhibit.
- Procure material in consultation with the artists.
- Organize exhibits.
- Organize trips to culturally interesting places.
- Print catalogs.
- For their efforts, the City of Yalova will take one artwork from each artist for their collection.
- The remaining artwork will remain in Yalova for 2 years. They will also be protected during this period.
- The City of Yalova will organize and pay for a second exhibition in Istanbul. After this exhibition, they will bring the artwork back to the City of Yalova.

The responsibilities of Network Fluss

- For the event that will take place in the City of Yalova from August 20 until September 20, 2015, Network Fluss will select up to 30 artists and sign contracts with them.
- Collect material from the artists for the catalog.
- Publicize this cultural event at cultural offices in Berlin.
- Asri Sayrac is the first curator and press representative.

The responsibilities of the artists

- The artists can determine how long they will stay, as well as their arrival and departure dates. They must announce this information in due time, at the latest at the end of January 2015.
- If the artist wants to change the travel dates after the tickets have already been purchased, he/she will bear the cost for the new reservation.

- The artist is responsible for travel, health and accident insurance and bears the cost for them. He/She is also responsible and bears the cost for customs and visa matters and is obligated to settle them in time.
- We expect that the artists will use their time in the City of Yalova to pursue their artistic ambitions which are to culminate in several pieces of art that can be presented in the exhibit.
- The video artist will make at least one video film and present it.
- Another exhibition is planned in Istanbul. For this, too, artwork is to be provided.
- The artist agrees to give one of his/her artworks to the City of Yalova free of charge and allows his or her other works to remain in the City of Yalova for 2 years. Then, until October 20, 2017, at the latest, the artist will collect his artworks (save the one given to the City of Yalova) at his own expense. The artist will agree with the City of Yalova on the exact time of collection. Insurance charges for the transport will be paid by the artist.
- If the artist does not collect his/her artwork, it will automatically be added to the collection of the City of Yalova.
- The artist allows the City of Yalova to supply the artwork he/she made for the exhibition for the duration of said exhibition, until October 20, 2017, at the latest, to third parties.
- This includes the right to reproduce the artwork and use it in public relations work, including the exhibition catalog, the website of the City of Yalova/the exhibition, as well as media reports on the radio and the internet.
- Photo images and resumes are still needed for the catalog, which the artist agrees to provide on time. Exactly what is needed will be announced by Network Fluss soon.
- In accordance with the statutes of the society, the event is neither political nor religious in nature.
- The artist sends this contract back either per post or per e-mail (scanned).
